Questions & Answers

This Guide provides an update on the approval status (including the Emergency Use Authorization), availability, and distribution of the COVID-19 vaccine.

In order to assist healthcare employers in planning for availability of the vaccine and answer many of the questions that they will face in deciding on the best approach for their operations, a series of frequently asked questions and answers have been prepared. These Q&As incorporate information provided in the EEOC's December 16, 2020 guidance regarding COVID-19 vaccinations.

*included under separate cover within the Toolkit zip file, as Appendix F This Toolkit includes two different policies for healthcare and long-term care facilities: (1) a policy in which employee vaccinations are recommended (**non-mandatory**) for employees; and (2) a policy in which employee vaccinations are required (**mandatory**) for employees, recognizing that exceptions may be required in order to comply with applicable law. The policies need to be customized for an employer's use with the help of the Guide/Q&As.
